Waiver of Liability, Photography Release, Privacy Notification and Payment Agreement

For and in consideration of participant's registration with Rivertown Sports Management LLC, (hereafter Rivertown Sports) and being allowed to participate in Rivertown Sports events and member team activities, the participant and/or parent(s) or legal guardian(s) of participants relinquish any and all liability for an cause of action for personal injury, property damage or wrongful death occurring to participant arising out of participation in Rivertown Sports events, member team activities, the sports of inline hockey and inline skating, and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant may have are hereby relinquished and the participant (or parent(s)/guardian(s)) does(do) so on behalf of my/our and participant's heirs, executors, administrators and assigns.

Participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume all risks inherent in inline hockey and skating and any member team activities, and understand that said sports and activities involve risks to participant's person including bodily injury, partial or total disability, paralysis, and death, and damages which may arise therefrom and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of others, including the "releasees" identified below. It is further acknowledged that there may be risks and dangers not known to use or are not foreseeable at this time.

Participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of inline hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said rinks, for negligent selection of certain releasees, or negligent supervision or instruction by releasees.

Participant or participant's parent(s)/guardian(s) agree if any claim for participant's personal injury or wrongful death is commenced against releasees, he/she shall defend, indemnify and save harmless releasees from any and all claims or causes of action by whomever of wherever made or presented for participant's personal injuries, property damage or wrongful death.

It is the purpose of this agreement to exempt, waive and relieve releases from liability for personal injury, property damage, and wrongful death caused by negligence, including the negligence, if any, of releases. "Releasees" include Rivertown Sports Management, LLC, its member teams, event hosts, other participants, coaches, officials, sponsors, advertisers, owners, and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees.

Participant and/or participant's parent(s)/guardian(s) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of releasees, that they are fully advised of the potential dangers of inline hockey and skating and understand these waivers and releases are necessary to allow amateur inline hockey and skating to exist in its present form.

Participant' and/or participants parent(s) or legal guardian(s) acknowledge that audio and/or video recording equipment may be in use at any time and that no expectation of privacy should exist inside the facility and/or on the outside premises. In addition, participant and/or participant's parent(s) or legal guardian(s) hereby permit Rivertown Sports to make and/or use, in whole or in part, photographs, videos, written extractions, and voice recordings of the participant, without enumeration, for whatever reason, including but not limited to; promotional or training materials, security evidence, retail products, etc.

Participant and/or participant's parent(s)/guardian(s) acknowledge that they are entering into a contract that requires payment per their team's league hockey agreement. \$25.00 fee will be charged on all returned checks. At its discretion, Rivertown Sports may issue refunds or credits prior to the registration deadline. After the registration deadline, Rivertown Sports shall not be obligated to issue refunds or credits under any circumstances.
